Supervisor Floyd Calkins called the meeting to order at 7pm.

Town Clerk Denise Hafner took a roll call of Board members present: Supervisor Floyd Calkins, present Councilman Rick Shoults, present Councilwoman Brenda Wilson, present Councilwoman Virginia Wilbur, present

Public Session: Heather Ladd raised the following questions directed to the Town Board members:

- 1. This question goes to all board members- After speaking with Floyd and another board member- I would like to know what better qualifications Greg had over mine.
- 2. Why didn't the board follow past practice by reaching out to the Republican committee for appointment?
- 3. After some research and reading into the NYS Comptroller report- did the Hannibal Town Budget for 2021 exceed the tax cap of 1.56%?
 - a. If so, was there a public hearing or vote on it? I do not recall.
- 4. With the county budget cutting taxes by 3%, every town around us not raising taxes, why couldn't the town have a balanced budget?
- 5. The 2021 has three tax raises- town, water, and fire department. With OCWA raising their prices for 2021, why couldn't the town keep customers rates the same as OCWAs to help alleviate some of the tax burden off residents?

Supervisor Floyd Calkins stated that some of the questions would be answered as the Board meeting continued. He suggested that she email the questions to him and he and the Board would try to address them.

Old Business:

- Supervisor Floyd Calkins emailed Mayor Ron Greenleaf about the Town & Village Inter-Municipal Agreement. Mayor Greenleaf insists that Code Enforcement Officer Carl Emmons, Jr. does not use the Town's Williamson Law Code Enforcement Software for the Village. However, CEO Carl Emmons, Jr. informed Supervisor Floyd Calkins that he does utilize the software when acting as the Village Code Enforcement Officer. The Village portion would be \$125 annually. Councilwoman Brenda Wilson suggested removing it from the agreement so the contract could be implemented. The Board concurred and also agreed to review the agreement annually with the Village.
- Highway Superintendent Jake Malcott reported that the county had not yet provided a quote for participation in their highway radio system.
- Highway Superintendent Jake Malcott would like to list some Highway Department equipment on Auctions International for sale. Councilman Rick Shoults made a motion to approve the following resolution; seconded by Councilwoman Virginia Wilbur.

BE IT RESOLVED THAT the Hannibal Town Board approves to increase the Hannibal Water Department Water Rates as follows: 5/8 inch meter EDU rate will increase from \$35/quarter to \$40/quarter based on the base usage of 6,500 gallons. The 1 inch meter base fee will be \$158 (an increase from \$138.79) for 31,688 gallons; the 1 ½ inch meter base fee will be \$222 (an increase from \$194.31) for 51,188 gallons and the 2 inch meter base fee will be \$324 (an increase from \$283.61) for 82,875 gallons. The price per 1,000 gallons (over minimum usage) will increase from \$3 to \$3.60

FURTHER RESOLVED, that in accordance with Article 57-A: (a) only those records will be disposed of that are described in *Retention and Disposition Schedule for New York Local Government Record (LGS-1),* after they have met the minimum retention periods described therein; (b) only those records will be disposed of that do not have sufficient administrative, fiscal, legal, or historical value to merit retention beyond established legal minimum periods.
