• The Board discussed a letter being sent to The Hannibal Fire Company regarding the 2022 Fire Protection Contract between the Town of Hannibal and the Hannibal Fire Company. Town councilman Greg Hilton has been in contact with Fire Chief Carl Emmons Jr. regarding setting up times to meet to discuss any contractual changes for the year 2022.

Other Business: Supervisor Floyd Calkins discussed with the board the possibility to change phone and internet service from Frontier to Spectrum. The current bill for 3 lines for Frontier is \$400 a month and an Estimate of \$160 was given from Spectrum. The Towns Contract ends with Frontier in June of 2022 and if we cancel service there is an approximate \$1,100 fee. Town Supervisor Floyd Calkins will look into Options.

The Board discussed ARPA- America Rescue Plan Act- Grant- suggestion of adding Cameras and audiovisual for live streaming in the future and possibly an intercom system at the doors were discussed. Supervisor Floyd Calkins will look further into uses and amount of grant.
