**Resolution 40 -2022**

**BE IT RESOLVED THAT the Hannibal Town Board approves to amend Local Law 2-2007 expanding ATV use of Town roads as follows:**

- **Rochester Street from the Village line to the intersection with Sixty Six Road**
- **Sixty Six Road from the intersection with Rochester Street to Onionville Road**
- **Mill Street from the Village line to the intersection with Blythe Road**
- **Blythe Road from the intersection with Mill Street to Wiltsieville Road**
- **Wiltsieville Road from the intersection with Blythe Road to Crandall Road**

**And to set/advertise a Public Hearing on 5/18/22 at 7:15pm**
