- Supervisor Floyd Calkins gave an update on the NYCLASS Investment Pool and explained that during
 the pandemic interest rates had decreased and the money had been moved from NYCLASS to money
 market accounts earning higher interest rates. Today, due to inflation, interest rates have increased and so
 the money has been moved back to the NYCLASS Investment Pool which will increase profits.
