Supervisor Floyd Calkins presented and explained several modifications for the 2023 Town of Hannibal Preliminary Budget. After reviewing, Councilman Greg Hilton made a motion to approve the following resolution; seconded by Councilwoman Tara Clark.

**Resolution 86-2022**

**BE IT RESOLVED THAT the Hannibal Town Board approves the following modifications to the 2023 Town of Hannibal Preliminary Budget:**

- Increase DA2300 [County Snow Plowing] from \$179,680 to \$202,140 (Difference of \$22,460)
- Increase DA5130.466 [Diesel] from \$15,000 to \$28,000 (Difference of \$13,000)
- Increase DA5142.466 [Diesel] from \$20,000 to \$29,460 (Difference of \$9,460)
- Increase A1410.12 [Deputy Clerk] from \$11,648 to \$12,688 (Difference of \$1,040)
- Increase A9030.8 [Social Security] from \$16,185 to \$16,264 (Difference of \$79)
- Increase A1620.462 [T/H Electric] from \$4,600 to \$5,500 (Difference of \$900)
- Decrease SW2-8310.13 [Water Clerk] from \$3,504 to \$3,124 (Difference of \$380)
- Decrease SW3-8310.13 [Water Clerk] from \$5,472 to \$4,879 (Difference of \$593)

- Decrease SW4-8310.13 [Water Clerk] from \$624 to \$556 (Difference of \$68)
- Decrease SW2-9030.8 [Social Security] from \$1,528 to \$1,499 (Difference of \$29)
- Decrease SW3-9030.8 [Social Security] from \$2,283 to \$2,238 (Difference of \$45)
- Decrease SW4-9030.8 [Social Security] from \$239 to \$234 (Difference of \$5)
- Decrease SW2-8310.444 [Supplies] from \$17,380 to \$4,380 (Difference of \$13,000)
- Decrease SW2-2140 [Metered Water Sales] from \$97,016 to \$96,607 (Difference of \$409)
- Decrease SW3-2140 [Metered Water Sales] from \$152,151 to \$151,513 (Difference of \$638)
- Decrease SW4-2140 [Metered Water Sales] from \$16,873 to \$16,800 (Difference of \$73)
