Peggy Shepard suggested that the Earth Day Town Clean Up could also be a time to maintain the park area.

Missy Hoefer asked for elaboration on the restroom facility suggested. Councilman Greg Hilton responded that it would be a full service restroom. She also asked whether the facility would be open and available in the evening. Councilman Greg Hilton stated that the facility would be open during the evening hours and that it would have lighting.

Councilwoman Tara Clark suggested having a security camera to help monitor the area for any possible vandalism. She also read a letter submitted by County Legislator Noelle Salmonsen in support of using the ARPA Funds to make improvements to the Community Park.
