New Business:

- Supervisor Floyd Calkins opened the only sealed bid received for the siding of the Municipal Building. C.L.A.W. Construction submitted a bid in the amount of \$38,500. Councilman Greg Hilton stated he would need to abstain from voting due to personally knowing the owner of C.L.A.W. Construction. The Board decided to table the matter until the August Board Workshop meeting due to not having enough Board members to make a quota.
- The Board discussed updating the Zoning Laws and hiring a second Code Enforcement Officer to assist CEO Carl Emmons, Jr. After the discussion, Councilman Greg Hilton made a motion to hire a second Code Enforcement Officer and to approve the following resolution; seconded by Councilwoman Tara Clark.

Resolution 49-2023

BE IT RESOLVED THAT the Hannibal Town Board approves the creation of a second Code Enforcement Officer position to be funded with ARPA Funds for two years at \$13,000 per year.

BE IT RESOLVED THAT the Hannibal Town Board approves to finance the purchase of the new International Plow Truck through KS State Bank in the amount of \$247,872.30 at an Interest Rate of 5.990% and a \$50,000 Down payment leaving the Principal Balance of \$197,872.30. The loan will be for a three year term with the first payment of \$74,012.27 due one year from closing.
